VARIATION

The enterprise agreement is hereby amended by:

- 1. Deleting clause 5, "Application and Scope" and inserting in lieu the following:
 - a) This enterprise agreement shall be binding upon:

Workforce International Pty Ltd (ACN007775435) and The Australian Workers' Union, representing their members, employees of the company, in respect to employment conditions and rates of pay for the company's employees, employed in regard to clients' of the company engaged in the following:

Venue operation and or maintenance.

Exhibition construction or staging.

Sporting fixtures (excepting employees engaged at Leichhardt Oval and Parramatta Stadium in relation to rugby league fixtures, in which case the terms and conditions of the Theatrical Employees Recreation and Leisure Industry (State) award 1997 shall apply). Entertainment (live or recorded).

- b) Notwithstanding any provision of this agreement, it shall not operate in circumstances where the Sydney Olympic and Paralympic Games 2000 (State) Award operates.
- c) Notwithstanding any provision of this agreement it shall operate in circumstances where the award known as the "Olympic Labour Network (State) Award", applies.
- d) Sub-clauses (b) and (c) , above, shall cease to operate when the Sydney Olympic and Paralympic Games 2000 (State) Award and the Olympic Labour Network (State) Award is rescinded or ceases to have effect.
