Application by the National Union of Workers, New South Wales Branch, industrial organisation of employees.

(No. IRC 2555 of 1995)

ORDER

The Commission orders that —

1. The Rubber Workers (State) Conciliation Committee published 21 May 1993 (275 I.G. 147) be dissolved and there be established a new Rubber Workers (State) Conciliation Committee for the Industries and Callings of:

All persons engaged in the State, excluding the County of Yancowinna —

- (a) engaged on any operation in or in connection with or incidental to the handling, preparation, manufacture or repair, (including use and operation of visual display units) of —
1. (i) rubber;
 - (ii) rubber goods;
 - (iii) goods containing rubber;
 - (iv) goods in manufacture or which rubber is used;
2. (i) thermoplastics and/or thermosetting plastics;- (ii) thermoplastics and/or thermosetting plastic articles or goods;
- (iii) articles or goods containing a thermoplastic and/or a thermosetting plastics;
- (iv) articles or goods in the manufacture of which a thermoplastic and/or a thermosetting plastic is used;

3. duperite, bakelite, casein or similar compositions, synthetic, rubberlikes, gut taperchalikes, rubberlike plastics, nitrocellulose, celluloid, leathercloth and elastomers, and goods of or containing any of the foregoing substances:

(b) engaged on any operation in or in connection with or incidental to (including use and operation of visual display units) the laying and fixing to any surface of —

 - (i) rubber;
 - (ii) plastic material;

(c) engaged on any operation in or in connection with or incidental to the handling preparation, manufacture or repair, (including use and operation of visual display units) of transmission cables which encompasses power and communication cables (including single strand) whether insulated or not;

(d) engaged on any operation in or in conjunction with or incidental to the handling, preparation, manufactures or repair, (including use and operation of visual display units) or abrasive wheels and stones, bounded abrasives, articles or goods containing a thermoplastic and/or a thermosetting plastic and allied products;

(e) in or about the manufacture of composition cricket balls; and

(f) by employers whose main business is the manufacture or repair of rubber tyres, in the fitting of such tyres;

excepting employees of:

The Council of the City of Newcastle;
The Commissioner for Motor Transport;
State Rail Authority of New South Wales;
Urban Transit Authority of New South Wales;
Metal Manufactures Limited in and about the company's work at Port Kembla;

and excepting also employees engaged in plastic moulding in synthetic resin or similar materials and preparation of powders and tablets when prepared in association with such mouldings otherwise than in the rubber industry or in an industry which manufactures goods by plant and equipment which is normal to the rubber industry;

and excepting also employees within the jurisdiction of the Saddlery, Leather, Canvas and Plastic Material Workers, &c. (State) Industrial Committee.

2. The said committee shall consist of one representative of employers and one representative of employees.
3. The representative of employers shall be appointed, upon nomination as prescribed, one by the Chamber of Manufactures of New South Wales (Industrial).
4. The representative of employees shall be appointed, upon nomination as prescribed, one by the National Union of Workers, New South Wales Branch.
5. This order shall take effect on and from 11 December 1995.
